Therefore, these rules apply to all transportation (special event- weddings) provided by Boston 5 Star without exceptions. The following rules also apply:

1. Boston 5 Star Limousine, Inc. agrees to provide the designated vehicle and a driver at the time, and date and locations specified on contract.
2. Unless specified on the contract, request for additional hours will be provided only if the vehicle is not schedule for other work.
3. Number of passengers allowed in the vehicle shall be no more than specified number in the contract or limited to the vehicle passenger capacity.
4. Boston 5 Star Limousine, Inc. has the right to substitute a vehicle of equal or greater value in the event of mechanical difficulties or scheduling reason.
5. Boston 5 Star Limousine, Inc. and B5SL employees are **not Responsible for any person items left behind or in the vehicle.**
6. NO drugs, under age drinking is allowed in the limousine. The chauffuer has the right to check identification to make sure that all persons in the limousine are of age if alcohol is present in the rear of the limousine.
7. Any persons that vomit inside the limousine a cleaning fee of \$600.00 will be allpied to the credit card on file.
8. The client agrees to a non fundable deposit of \$200.00, unitl a deposit is taken the vehicle then will be considered reserved.
9. The client agrees that a cancellation fee will apply half the the total amount if the vehicle is cancelled within one week.
10. The client agreees that if an act of God or unforeseen acts happen say the limousine gets into an accident prior to schedule pick up that Boston 5 Star Limosuine is not held responsible for not showing up on time.
11. If the limosuine is late than by more than 15 minutes Bostn 5 Star Limousine will give a discount of 50% percent of the agree rate for the occassion.
